

# 2010 ACTA Tennis Lesson Program

*“Serving the area’s tennis needs for ten years”*

- ⇒ Select your class and fill out the sheet listed below. Mail with a payment and membership form to address. To obtain a membership form go to [www.algtennis.org](http://www.algtennis.org) The cost of a family membership is \$10 annually and can be included in the same check. Grades are for the 2010-11 school yr.
- ⇒ The Algonquin Community Tennis Associations teaching program incorporates concepts from the USPTA’s Little Tennis, USA 1-2-3 and the more modern quick start tennis as well as over 15 years of high performance training methods with high school and adult players.
- ⇒ These lessons are designed to have between 2-6 student per instructor ratio. Players are grouped on court by a combination of *ability* and age. Class sizes will vary depending on enrollment. We will try and keep siblings together to offer the easiest possible transportation. For example if you have a pee-wee and grade school child they may attend the PW-4 class at same time but will be put on separate courts.
- ⇒ To accommodate the overall program it is possible that some students might be switched to a different class or time. If you **do not hear** from us you have been added and you only need to show up on the first day of lessons. **Contact Coach Gablenz at [dgablenz@sbcglobal.net](mailto:dgablenz@sbcglobal.net) or 847-772-2401 for more information on a limited number of openings for classes held on Wednesday evenings and Saturday mid afternoon at Willoughby.**
- ⇒ Refunds will not be granted for missing lessons. Our staffing is based off of enrollment numbers. However, all attempts will be made to make up a missed lesson if mentioned ahead of time. When canceling with at least one week prior notice we will honor a full refund.
- ⇒ New this year is the Saturday time slot for Adult lessons along with a convenient time for child as well.
- ⇒ 2010 summer rates were lowered from previous year to be sensitive to current economy. The Fall prices remain the same.
